### To Whom It May Concern:

Falls Area Single Track, Inc. (FAST) is a local chapter of the International Mountain Bike Association (IMBA). FAST is a 501c3 non-profit based in Sioux Falls, SD and is the only IMBA chapter in the state. Our mission is to protect, create, and enhance quality trail experiences for mountain bikers in cooperation with other trail users in the Sioux Falls area. FAST actively promotes responsible trail use, supports volunteer trail work, assists land managers with trail management issues, and improves relations among all trail user groups. Through usage agreements with the City of Sioux Falls, FAST currently maintains around eight miles of multi-use, dirt trails (open for biking, running, hiking, etc.) at Leaders Park, Tuthill Park and Yankton Trail Park along the Big Sioux River Greenway.

FAST is applying for a 2019 South Dakota Recreational Trails Program Grant to facilitate the design and construction of up to four wooden bridges and 3 trailhead signs with maps as part of the multi-use singletrack trail inside Tuthill Park in Sioux Falls, SD. FAST, working with a private contractor, constructed 2+ miles of singletrack in Tuthill Park during 2018. There are multiple drainage crossings of varying lengths throughout the trail network that have temporary bridges installed. The next step is to install permanent sustainable bridges. Permanent trailhead signage is also required to bring the project to completion. Tuthill Park is open to the public and is managed by the Sioux Falls Parks and Recreation Department (SFPR). FAST and SFPR have a usage agreement in place that enables the establishment, maintenance, and use of singletrack trails in specified parks. This agreement is included at the end of our proposal.

FAST proposes to work with volunteers for construction of the bridges and trailhead signs. Bridges will be constructed in similar fashion those detailed in the included USDA/US Forest Service document. The existing trail is a natural surface consisting of packed dirt with some stone hard-facing. Bridges will be designed to fit harmoniously with the natural topography of the land. The trailhead signs will be constructed of wood and be similar in appearance and design to the Leaders Park Trailhead sign shown in the included documentation. Non-motorized users including, but not limited to, mountain bikers, trail runners, and hikers will be permitted to use the trail at no cost making this a true enhancement to the city. The trail will be accessible from parking lots within Tuthill Park and an access point along the Sioux Falls Bike Trails. Long-term maintenance of the trail system will be managed by FAST with volunteer labor at no cost to the City of Sioux Falls.

In 2018 FAST secured sufficient funding to complete the professional construction of 2+ miles of trail. Donors included local bike shops, businesses, and more than 130 individual trail enthusiasts. With the investment of local businesses and the influx of individual donors, FAST is confident that the SD RTP grant will help bring this project to successful completion and directly support the desires of many in our community.

### Project Description:

In 2016, FAST was granted access to a large area of Tuthill Park in Sioux Falls, SD to establish and maintain a multi-use singletrack trail. This access is granted through a usage agreement established with the Sioux Falls Parks and Recreation Department.

FAST engaged Trail Arts to develop a detailed proposal to design and build singletrack trail in Tuthill Park. Throughout late 2017 and 2018, FAST was able to raise sufficient funding to hire Trail Arts to construct 2+ miles of Trail in Tuthill Park. FAST intends to bring Trail Arts back this spring to complete an additional .5 mile of trail construction.

FAST is requesting RTP Grant funding to facilitate the construction of permanent bridges over 4 drainage areas which are crossed by the trail and add 3 permanent trailhead signs with trail maps at the 3 entrance points to the trail. Money will be used for bridge and sign materials such as lumber, hardware and paint and to have weather resistant metal trail map signs printed.

The trail surface is packed dirt with some stone hard-facing. Bridges will be constructed of pressure treated dimensional lumber and anchored with stone and concrete as needed to ensure long term sustainability. Bridge design will be similar to what is detailed in the included USDA/US Forest Service Bridge Design document. Trailhead signs will be built to match the existing trailhead sign at FAST's singletrack trail at Leaders Park in Sioux Falls.

FAST volunteers will be utilized to aid in bridge and trailhead sign construction.


### Long Term Commitment:

As noted above, FAST has a long term usage agreement with the Sioux Falls Parks and Recreation Department. Throughout the trail use season, FAST schedules weekly trail maintenance and cleanup sessions. These sessions are tailored to the needs of the week and can include tree and grass trimming, erosion repair, litter pickup and trail expansion.

I am writing this reference at the request of Falls Area Single Track (FAST), who is applying for a Recreational Trail Program grant to facilitate the construction of singletrack trails in Tuthill Park in Sioux Falls, SD. FAST has maintained a usage agreement with the Sioux Falls Parks and Recreation Department (SFPR) since 2010 which allows for the establishment and maintenance for multi-use singletrack trails within specified parks in the Sioux Falls area.

The trails developed and maintained by FAST have provided new opportunities for outdoor recreation that didn't previously exist in Sioux Falls.
